### Lady Evelyn Park Cluster Fire Update

The Lady Evelyn Park cluster is managed by the Dale Horan Incident Management team from Ontario. This team will transition to Ontario's Bob Hurley team July 24. The fire is now 27,579 hectares. 238 firefighters and support staff and 11 helicopters are assigned to North Bay 72. The team continues to observe North Bay 59.

#### North Bay 72

- Rain brought welcome relief to the fire today allowing crews to regroup from yesterday's extreme day. The northeast portion of the fire received between 8 and 13 mm, the southwest portion received 25 to 31 mm and the northern portion between 11 and 20 mm of rain.
- Crews will continue to work hose lines on the perimeter of the fire.
- Sprinklers continue to run on values on Mendelssohn Lake, Skull Lake and Cook Lake.
- We currently have firefighters from British Columbia, Alberta, Ontario, Nova Scotia, Newfoundland and the Northwest Territories and Mexico.
- The Implementation Order has been extended.



#### Forecast and weather information




#### **Tuesday's Forecast**

Mostly cloudy with scattered showers. A risk of isolated thunderstorms in the afternoon and evening. Rainfall amounts predicted to be a trace to 5 mm. Winds will be southwest from 10 - 15 km/h with a high 21C and relative humidity up to 80%.

#### **Travel Restrictions**



The Ministry of Natural Resources and Forestry is prohibiting access in portions of North Bay, Sudbury and Kirkland Lake Districts where there are public safety hazards. Crown land camping, boating, daytripping, hiking, ATVing as well as accessing private or commercial camps or cottages are not permitted in the area covered by the travel restrictions.

#### **Restricted Fire Zone**

A Fire Restriction remains in effect.

When a Restricted Fire Zone is declared, it is illegal to set a fire within the affected area. Failure to comply could result in a fine of up to \$25,000 and three months in jail, as well as the financial responsibility for any costs incurred in fighting a forest fire caused by the illegal act. If you need heat for cooking and warmth, you must use a portable gas or propane stove. Portable charcoal equipment (ex. BBQs, Hibachis, etc) are illegal for use during a Restricted Fire Zone, except close to a dwelling you legally own or occupy or in an organized campground.

A waterbomber will not scoop from a lake or river if encroaching watercraft pose a safety hazard.
