Temagami Cluster Fire Update

The Temagami Cluster is currently managed by the Garry Harland Incident Management Team (IMT) from Ontario. There are 45 firefighters, with 6 helicopters working on fires in the Temagami cluster.

Due to the rain received in the area, fire activity was reduced greatly on all fires within the Temagami Cluster. These conditions made for a great working day for firefighters, as they are able to get into hotspot areas safely. Crews continue to patrol and mop up: NOR55, NOR56, NOR68 and NOR69. Firefighters continue to monitor: NOR18, NOR19, NOR46, NOR47, NOR61 and action priority areas with heli-buckets.

Value protection systems remain on NOR55, NOR56, and NOR47.

North Bay 69, which previously caused the evacuation of twenty homes in the Temagami area, is now under control. Firefighters continue to focus on working their way deep into the interior of the fire to check for hot spots.




Tuesday's Forecast

A mix of sun and cloud with a chance of thunder showers is expected again for tomorrow. The temperatures will rise to 20C. Winds will be out of the south at 5km/h. Relative humidity values are expected to be high into the 95% range.

Travel Restrictions



The Ministry of Natural Resources and Forestry is prohibiting access in portions of North Bay, Sudbury and Kirkland Lake Districts where there are public safety hazard areas, due to increased fire activity. Crown land camping, boating, daytripping, hiking, ATVing as well as accessing private or commercial camps or cottages are not permitted in the area covered by the travel restrictions.

Restricted Fire Zone

A Fire Restriction remains in effect.

When a Restricted Fire Zone is declared, it is illegal to set a fire within the affected area. Failure to comply could result in a fine of up to \$25,000 and three months in jail, as well as the financial responsibility for any costs incurred in fighting a forest fire caused by the illegal act.

If you need heat for cooking and warmth, you must use a portable gas or propane stove. Portable charcoal equipment (ex. BBQs, Hibachis, etc) are illegal for use during a Restricted Fire Zone, except close to a dwelling you legally own or occupy or in an organized campground.


