# Lady Evelyn Park Cluster Fire Update

The Lady Evelyn Park Cluster continues to be managed by the Bob Hurley Incident Management Team (IMT) from Ontario. This cluster includes the following fires North Bay 18, 19, 46, 47, 59 and 72.

FireRangers will be deployed to the south end of North Bay Fire 19 on August 1, 2018 to begin suppression efforts. This fire has been smoking a bit and shows heat on the infrared scans.

The MNRF continues to advise the public that an Implementation Order in the Elk Lake and Lady Evelyn area remains in effect and restricts access to certain roads, parks and Crown lands. Road blocks have been set up to notify the public of the closures. Within the restricted area, Crown land camping, boating, the landing of float planes, day-tripping, hiking, ATVing as well as accessing private or commercial camps and cottages is NOT permitted. Permits are required to travel through the restricted area. MNRF will maintain the Implementation Order in the Elk Lake and Lady Evelyn area as long as needed to ensure the safety of the public and FireRangers working in the affected area.

Travel restrictions in the River Valley area have been rescinded as of 1600hr on July 31, 2018.

The MNRF truly appreciates the public's ongoing patience, cooperation and support during this busy fire season.



# North Bay 72

- The fire is classed as not under control and is approx. 27,285 hectares.
- There were a few smokes and hot spots observed again today but no notable fire activity.
- Values protection equipment remains in place for camps and cottages located on Mendelssohn Lake and Skull Lake.
- There is over 12km dozer guard along the northwest head of the fire.
- There are over 200 front line FireRangers assigned to this fire.



# The Restricted Fire Zone Remains in Place!

The MNRF reminds the public that there is currently a Restricted Fire Zone in place for much of northeastern Ontario.

Some municipalities and townships have lifted their fire bans which are different than a Restricted Fire Zone implemented by the MNRF under the Forest Fires Prevention Act.

A Restricted Fire Zone is a temporary measure for extreme situations. As soon as outdoor conditions permit, the restrictions are lifted.

#### **Travel Restrictions**


The Ministry of Natural Resources and Forestry continues to advise the public that due to the current forest fire situation in the Elk Lake and Lady Evelyn area, an Implementation Order remains in effect that restricts access to certain roads, parks and Crown lands. **Travel restrictions in the River Valley area have been rescinded.** 

Access to areas within the Implementation Order area is restricted and road blocks have been set up to notify the public of the closures. Within the area, Crown land camping, boating, the landing of float planes, day-tripping, hiking, ATVing as well as accessing private or commercial camps and cottages are NOT permitted. Permits are required to travel through the restricted area.

# **Restricted Fire Zone (RFZ)**

A Restricted Fire Zone remains in effect for the majority of northeastern Ontario.

When a Restricted Fire Zone is declared, it is illegal to set a fire within the affected area.

Failure to comply could result in a fine of up to \$25,000 and three months in jail, as well as the financial responsibility for any costs incurred in fighting a forest fire caused by the illegal act. If you need heat for cooking and warmth, you must use a portable gas or propane stove. Portable charcoal equipment (ex. BBQs, Hibachis, etc) are illegal for use during a Restricted Fire Zone, except close to a dwelling you legally own or occupy or in an organized campground.
