## 4.1 HR Update

Katie M. provided an overview of details in her Staff Report. Katie stated that the Draft TFN Personnel Policy has be provided to TFN staff and she will need to schedule a day for staff to review the policy with Managers. Katie informed Council that the HR Downloads training program has been purchased.

## 4.2 Capital Projects/Community Infrastructure

Jamie K. informed Council that January 31st marked the date for Substantial Completion of the Minowaabandan-gamiing Maawanjihidiwining (Lakeview Gathering Place). This date is significant as it initiates the start date for the one (1) year warranty of the building with the General Contractor. It also marks the date of the sub-contractors forty-five (45) day window to seek payment if they have not been paid for sub-contract services. Jamie also let Council know that the General Contractor will be presenting a claim in early March for monies they believe they are owed.

Jamie K. informed Chief and Council that the Elders' Complex project was a little behind at the Christmas/New Year's break, but the project is now back on schedule and it is anticipated that the Move In date for tenants will be this coming September. Jamie K. said that the Housing department has created

intake forms to assist the application process for the Elders' Complex. However, Jamie K. questioned if the TFN has an actual Roll Out plan for tenants to move in or would more consultation with the community be required.

Jamie K. told Chief and Council that the TFN Police Office in the new Minowaabandan-gamiing Maawanjihidiwining is on schedule to be substantially complete by April 28<sup>th</sup>.

Jamie K. let stated that engineers had inspected the engineered support beams in the gym at the LMLC and they have expressed some concern as the integrity of the beams have been compromised. Jamie K. stated that now would be the time for TFN representatives to be lobbying for funding to seek expansion and/or structural repairs funds from agencies as this is normally the time of year in which funding is awarded.

Jamie K. mentioned that she has a few matters that she will be addressing in a Staff Report to be brought to the next Council meeting that she wanted to make Chief and Council aware. She stated that she will be requesting Council to consider the differences between buying versus leasing in getting a new vehicle for Chief and Council travel. Jamie K. stated that the lease for the red Buick is up in March and the amount owing for going past the annual allowance for mileage is going to be considerable – it would probably make more sense to buy out the vehicle.

Jamie K. stated that she needed direction from Council as to where the Public Works Yard will be located. After a bit of discussion, it was decided that the TFN will be proceeding with the plan for the Public Works yard. Jamie K. also asked Chief and Council to consider purchasing a new hoist for the Public Works building. The Chief and Council directed Jamie K. to price out some hoists that may be purchase for the Public Works building.
