#### a) Staff Report Renaming Bear Island Roads

Jamie presented to Chief & Council that the former Council decided to move ahead with implementing 911 services for Bear Island, as they were faced with the possibility of an evacuation because of forest during the summer 2018, as well as, for the most recent Pandemic issue. Unfortunately, during these situations, when bringing in an outside agency to assist, could have proved to be a very serious problem in terms of an accurate and successful evacuation. Temagami First Nation then engaged with DJS & Associates Inc. to start the process of implementing this service to Bear Island. Debra J Smith, the president of DJS & Associates came to Bear Island for an initial field visit to the community to identify any areas of concern. Debra then asked TFN for clarification on 14 areas of concern. TFN has until December 31, 2020 to finish this project.

Discussed that O'Jeeg Ave shows on the map as starting off Kohoja Ave and is designated as a road; this road is currently named O'Jeeg Ave but is part of Chenjuse Ave which is a continuous road. Noted that this road will continue to be named O'Jeeg Ave.

Discussed that White Bear Road currently ends at the Grave Yard. The road will be named jiibegamigoon.

Noted that the road beside Delma's to Mac McKenzie's is not a road.

Discussed that "the loop" will be named Wawate Ave.
