The IESO allows multiple applications to be made to the IEP program, however, recipients are only eligible to receive up to a maximum of \$200,000 per year.

c) Staff Report re: IEP Waste Plant

The IESO allows multiple applications to be made to the IEP program, however, recipients are only eligible to receive up to \$200,000 per year.
