In October 2018, we started the process of developing a Master Land Use Plan for Bear Island and the Proposed Settlement Lands.

WHAT IS A MASTER LAND USE PLANNING?

Land use planning helps communities make informed decisions on how to conserve and develop their lands! A Land Use will:

- Define the long-term goals and vision for our land;
- Provide a set of policies and maps to guide future development of the land;
- Better conserve and protect local resources; and
- Considers how the physical environment (e.g., houses, shops, roads) interacts with the natural environment.

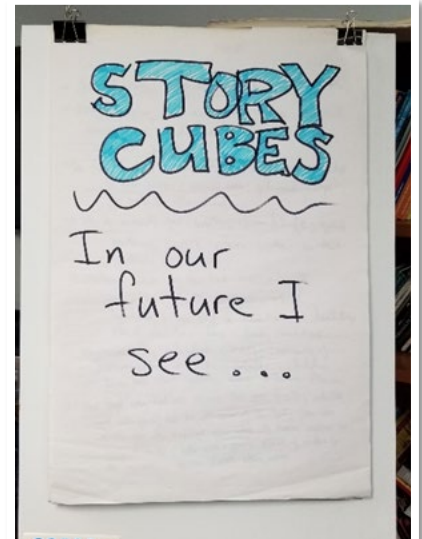




Where Are We At?

The Master Land Use Plan is the community’s plan and a plan for our future generations. We have been speaking with the community about the Land Use Plan since March 2019, but work started before then. Below is an overview of all community engagement events to date.
