## Temagami First Nation Lake Temagami Access Point Paid Parking Rules

The set of rules is to ensure that individuals leasing stalls are able to enjoy the use of the stall but also allowing the routine maintenance of the access point. Vehicles parked illegally in the paid parking areas will only be ticketed or towed if a complaint is received from the registered lessee of the stall in question, the complainant will be required to show identification when a complaint is made.

1. Maintenance of the site is the responsibility of Temagami First Nation; anyone found removing trees and/or enlarging parking stalls will be in contravention of these rules and will forfeit their parking stall.
2. TFN parking stalls will only be available to Bear Island residents and/or TFN Businesses.
3. TFN parking stalls are strictly for the use of the registered users including their guests, family, and other registered users to whom they have given permission to use the stall.
4. TFN will reallocate parking stalls as they become available.
5. Payment of parking stall fees is required by February 19<sup>th</sup>, after this date, if invoices are not paid on or prior to February 19<sup>th</sup>, the parking stall will be considered forfeited.
6. Parking stalls are for parking motor vehicles, motorized snow vehicles or ATV's.
7. A **MAXIMUM** of one motor vehicle is permitted to park in a stall at any one time.  
*"Motor vehicle" includes an automobile, and any other vehicle propelled or driven otherwise than by muscular power, but does not include a snowmobile or ATV.*
8. Trailers are not permitted to park in a stall at any given time, no exceptions.
9. Vehicles will not be park as to obstruct another parking stall or the flow of traffic on the main road.
10. For snow removal purposes, except for snowmobiles or ATV's, the storage of other material in a parking stall is not permitted between October 31<sup>st</sup> and April 30<sup>th</sup>.
11. **Sub-leasing or renting** of parking stalls is not permitted.

12. Every person leasing a parking stall from Temagami First Nation must provide a signed copy of the rules and return it to the Band Office.

**Any contravention of these rules may result in the forfeiture if the parking stall.**
